



## IKF ASSOCIATE REPRESENTATIVE APPLICATION

To apply to become an **IKF Associate Representative**, Please print off this application, complete and mail it, along with 2 Pictures of yourself to the **IKF**. You will be notified in writing within 30 days of the decision of your application. If you are declined you will be sent a written explanation of why. A minimum \$25.00 fee is charged for your application review process. If Approved, you will receive an Official **IKF Certificate** and your title and position will be placed on the **IKF Advisory Board** under the region of your position. Please mail to; **IKF, P.O. #### The Requirements Of An IKF Associate Representative (AR)

- You must be either an **IKF Promoter, Trainer or fighter "Actively Working with the IKF or willing to work with the IKF.**
- An **IKF Associate Representative (AR)** is an individual who is qualified to assist an **IKF Representative or Promoter** in the area of their Title. Example: A **USA-AR** can assist any **IKF Representative or Promoter** in any state in the USA on any **IKF Sanctioned Event.**
- An **IKF AR** may also act as the Event Representative if for some reason, the **IKF Representative** in the given area is unable to attend the event in question. If so, they will be paid for their full days work for the event **plus any travel expenses and food expense** while at the event city. Such work would include but is surly not limited to:
  - 1.Overseeing and recording all official fighters weights.
  - 2.Record all registration info from all fighters on the event to be recorded into the **IKF** rankings.
  - 3.Recording all scores and actions of each bout on the event.
  - 4.As the acting Event Representative, they will also have the authority and responsibility to assure all fighters & safety fairness of the event.
  - 5.To assure all pro purses are paid to all pro fighters.
- If an **AR** is "Not Working/Assisting" an **IKF Sanctioned Event**, but wishes to attend the event as a guest, they \*May attend for **Free** or at a discounted rate as long as they request such access to the **IKF** by e-mail at **Main@IKFKickboxing.com** and are granted permission by the **IKF Promoter** a minimum 1 week prior to the event they wish to attend.
- If allowed "FREE" admission, all guests attending the event with the **AR** must purchase their own event ticket unless additional tickets or access is provided by the event promoter.
- (\*) *If a promoter cannot offer a free seat due to limited seating, they may offer a discounted ticket fee to the **IKF AR** and 1 guest. Promoters are allowed to offer any discounts they desire. They are also allowed to "DENY" any **AR** Free Admission to their event if they feel they will not have seating available or for personal reasons whatever they may be.*
- An **AR** is someone who can be contacted to verify information for the **IKF** about individuals & events within their given title/area.
- If the **IKF Headquarters** and an **IKF event promoter** feel necessary, They may appoint an **AR** to assist any **IKF** event in their Represented area as an official judge, referee etc as qualified at the current officials fee rate. (As well as an **IKF Event Representative as explained above**)
- An **IKF AR** may volunteer their services on any **IKF** event in their area and such actions are encouraged and greatly appreciated.
- The **AR** can be a Trainer, Fighter, Official or Promoter.
- The **AR** can oversee **IKF Events and Activities** in a State, Region, Nation, Continent or Worldwide depending on what they apply for.
- **The Associated Representative is allowed to receive a financial percentage of fees of any new fighter, trainer, official, promoter or associate they personally recruit into the IKF on their own.**

### IKF State/Area ASSOCIATE Representative

An **IKF State / Area ASSOCIATE Representative** is an individual that assists various **IKF Activity** of there entitled State (EX: California USA) under the direction of the **IKF State Representative** and the **IKF World Headquarters**. They could receive a percentage of fees for new fighter registration, licenses and sanctioning fees of New **IKF Individuals** that **they recruit** into the **IKF**. They can also assist in the organization of event sanctioning and appointment of event officials along with the direction of their **IKF State Representative** and the **IKF World Headquarters**. Depending upon the size of the State or Area, there can be up to 10 State/Area ASSOCIATE Representative.

**Yearly Fee: \$100.00 (Year starts day of acceptance)**

### **IKF Regional ASSOCIATE Representative**

An **IKF Regional ASSOCIATE Representative** is an individual that assists various **IKF** Activity of there entitled Region under the direction of their **IKF** Regional Representative and the **IKF** World Headquarters. They could receive a percentage of fees for new fighter registration, licenses, recruited State or Area **Associates** Registration and Sanctioning Fees of New **IKF** Individuals that **they recruit** into the **IKF**..They can also assist in the organization of event sanctioning and appointment of event officials along with the direction of their **IKF** Regional Representative and the **IKF** World Headquarters. Depending upon the size of the Geographical Region, there can be up to 10 Regional ASSOCIATE Representatives per Region. **Yearly Fee: \$150.00 (Year starts day of acceptance)**

### **IKF Country ASSOCIATE Representative**

An **IKF Country ASSOCIATE Representative** is an individual that assists various **IKF** Activity of their entitled Country under the direction of their **IKF** Country Representative and the **IKF** World Headquarters. They could receive a percentage of fees for new fighter registration, licenses, recruited Regional, State or Area **Associates** Registration and Sanctioning Fees of New **IKF** Individuals that **they recruit** into the **IKF**. They can also assist in the organization of event sanctioning and appointment of event officials along with the direction of their **IKF** Country Representative and the **IKF** World Headquarters. Depending upon the size of the Country, there can be up to 10 Country Representatives per Country. **Yearly Fee: \$250.00 (Year starts day of acceptance)**

### **IKF Continental ASSOCIATE Representative**

An **IKF Continental ASSOCIATE Representative** is an individual that can assists **IKF** Activity of their entitled Continent under the direction of their **IKF** Continental Director or Continental Representative and the **IKF** World Headquarters. They could receive a percentage of fees for new fighter registration, licenses and Sanctioning Fees of New **IKF** Individuals that **they recruit** into the **IKF**. They can also assist in the organization of event sanctioning and appointment of event officials along with the direction of their **IKF** Continental Director, Continental Representative and the **IKF** World Headquarters. Depending upon the size of the Continentant, there can be up to 10 Continental ASSOCIATE Representatives per Continentant. **Yearly Fee: \$500.00 (Year starts day of acceptance)**
