- 4: If a Trainer, Be QUALIFIED & EXPERIENCED in the fighting Techniques of Kickboxing.
- 5: If a Gym, Have Professional Equipment for Professional Instruction & Training of Kickboxing.
- 6: Have been Trained and Certified by an Official IKF Trainer.
- 7: Paid all Required Introductory Franchise Application Fees of \$2,500.00 to the IKF.

You will be notified in writing within 30 days if you are not APPROVED and ENDORSED by the **IKF**. If your club is declined as an Officially Approved and Licensed **IKF** Kickboxing Gym/Club, **you will be refunded the entire amount**. If Approved, you will receive an Official **IKF** Licensed Franchised Business/Gym/Club Certificate to post on your Business – Gym - Club wall. Please mail to; **IKF P.O.
