I hereby consent & agree to completely accept alone any & all risks of injury or death.

3: Release: In consideration for (a) being accepted as a competitor of the **2021 IKF Amateur Muay Thai & Kickboxing World Championships**, (b) being entitled to participate in activities conducted and sponsored by the IKF (International Kickboxing Federation) and (c) being permitted to use facilities and equipment, whether owned or leased by The IKF and all associates, officials, employees, staff, The Hyatt Regency Orlando and fellow participants and trainers/coaches.
